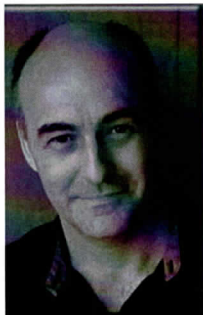
thank her husband Michael for his patience and support during the past three months.
